## **Overall Progress Narrative:**

The State of Illinois has made significant progress under NSP since the end of last quarter. As of the date of this QPR, June 30, 2010, 40% of the NSP resources are obligated. In one month since the date of this QPR, our current obligation total increased to \$32,358,311.46 or 60% of total NSP funding. Subgrantees around the State are moving along at a very rapid pace to negotiate purchase and construction agreements to obligate the remaining NSP funds. NSP projects range from rehabilitation of foreclosed single family homes for long term rental or homeownership to substantial rehabilitation of an abandoned motel for permanent supportive housing for veterans. We are closely monitoring progress of all subgrantees on a daily basis. The State of Illinois developed a reallocation plan and has already reallocated several million dollars to NSP grantees and subgrantees to expand and complete their NSP activities. With the rapid progress of our current subgrantees, the on-going implementation of our reallocation plan, and targeted technical assistance, we are executing all measures to achieve 100% obligation by our September 4, 2010 deadline.
