

TEFRA NOTICE

The Illinois Housing Development Authority (the "Authority") gives notice that it will hold a public TEFRA hearing on Tuesday, September 13, 2022 at 10:00 a.m., local time, in order to give the public an opportunity to comment on the proposed issuance by the Authority of tax-exempt bonds or notes in an amount not to exceed \$18,100,000 in aggregate principal amount (collectively, the "Bonds"), in one or more series, pursuant to a common plan of finance. The proceeds of the Bonds will be used to finance or refinance, through a new mortgage loan to the Owner listed below (or an affiliate thereof), (i) the acquisition, construction, rehabilitation and/or equipping of the multifamily residential housing property set forth below (the "Development"), an exempt facility as described in Internal Revenue Code Section 142(a)(7), (ii) any functionally related and subordinate facilities to the Development, and (iii) the costs of issuance for the Bonds. Anyone wishing to comment in writing should submit their written comments no later than 9:20 a.m., local time, on Tuesday, September 13, 2022, via e-mail to maohle@ihda.org or by delivery to the address below. Comments received by the deadline will be read aloud during the public hearing.
