



## **NOTICE OF PUBLIC HEARING**

The Illinois Housing Development Authority (the "Authority") gives notice that it will hold a hearing by video/audio and telephone as described below on Wednesday, June 18, 2025, at 9:00 a.m., local time, in order to give the public an opportunity to comment on the proposed issuance by the Authority of tax-exempt bonds or notes in an aggregate principal amount not to exceed \$43,578,000 (collectively, the "Bonds"), in one or more series, pursuant to a common plan of finance. The proceeds of the Bonds will be used to finance or refinance, through a new mortgage loan to the Owner listed below (or an affiliate thereof), (i) costs of the acquisition, construction, rehabilitation and/or equipping of the multifamily residential housing property set forth below (the "Development"), (ii) any functionally related and subordinate facilities to the Development, and (iii) costs of issuance for the Bonds. The Development will be owned by the Owner listed below (or an affiliate thereof). The Development will constitute a "qualified residential rental project" under the requirements of, Section 142(d) of the Internal Revenue Code of 1986, as amended.
