NOTICE OF PUBLIC HEARING

The Illinois Housing Development Authority (the "Authority") gives notice that it will hold a hearing by video/audio and telephone as described below on Thursday, July 24, 2025, at 10:30 a.m., local time, in order to give the public an opportunity to comment on the proposed issuance by the Authority of tax-exempt bond(s) or note(s) in an amount not to exceed \$15,610,000 in aggregate principal amount (collectively, the "Bonds"), in one or more series, pursuant to a common plan of finance. The proceeds of the Bonds will be used to finance or refinance, through a new loan to the Owner listed below (or an affiliate thereof), (i) costs of the acquisition, construction, rehabilitation and/or equipping of the multifamily residential housing property set forth below (the "Development"), (ii) any functionally related and subordinate facilities to the Development, and (iii) the costs of issuance, capitalized interest, and reserve funds, if any, for the Bonds. The Development will be owned by the Owner listed below (or an affiliate thereof).
