Report of Activities for State FY2022 and Projected Activities for State FY2023

Pursuant to the Illinois Housing Development Act, 20 ILCS 3805/5 et seq. (Act), the Illinois Housing Development Authority (Authority) submits this report on its activities for the fiscal year ending on June 30, 2022 (FY2022).

This report is broken down into four (4) parts. Part One lists all applications received by the Authority in FY2022. Part Two reports on the Authority's financing activities around the State of Illinois (State) during that time period. Part Three reports on the Authority's projected activities for the fiscal year ending on June 30, 2023 (FY2023). Part Four reports on the activities of the Strategic Planning and Reporting Department (SPAR).

The Authority administers the following programs: the HOME Investment Partnerships Program (HOME Program), the federal Low Income Housing Tax Credit (LIHTC) and State of Illinois Affordable Housing Tax Credit (IAHTC) Programs, the National Housing Trust Fund (HTF), the Illinois Affordable Housing Trust Fund (Trust Fund), the Rental Housing Support Program (RHS Program), the Abandoned Properties Program (APP), the Land Bank Capacity Program and Technical Assistance Network (LBCP), the Strong Communities Program (SCP), the Foreclosure Prevention Program (FPP), the Foreclosure Prevention Program - Graduated Fund (FPPG), the Cook County Mortgage Foreclosure Mediation Program (CCMFMP), and the Access Programs (including Access 4%, Access 5% and Access 10%), the Opening Doors Program, and SmartBuy Program single family mortgage financing. In FY2022, IHDA launched the second iteration of the Illinois Rental Payment Program (ILRPP) and the Illinois Homeowner Assistance Fund (ILHAF) programs statewide to promote housing stability during the COVID-19 pandemic.

APPLICATIONS RECEIVED IN FY2022

The Authority received a total of 532 applications seeking a total of \$1,850,419,706 in Federal and State resources in FY2022. These applications were for the creation or preservation of 25,516 units to the state. The Authority also received more than 27,325 applications seeking emergency assistance through the Illinois Rental Payment Program and Illinois Homeowner Assistance Fund. All eligible and complete applications for emergency assistance were approved and funded.

Bonds

The Authority received 41 applications seeking \$1,186,608,345 to construct 6,462 units of housing through its bond financing programs.

Of these bond applications, \$74,640,000 was requested through the Advantage Plus Mortgage and the Federal Financing Bank (FFB) Program.

HOME Investment Partnership Program

The HOME Program was created under Title II of the National Affordable Housing Act of 1990, as amended, and authorized by the Housing and Community Development Act of 1992. The Authority received a total of 4 applications to its HOME Program. These applications sought a total of \$12,142,660 in financing to fund 112 units of affordable housing. There were an additional 17 applications received through the Permanent Supportive Housing (PSH) Program, which can be funded with HOME monies. PSH applicants are listed in EXHIBIT VII: FY2022 Applications Report – Other Multifamily Financing Requests. All the applications were submitted for the construction of multifamily housing.

Tax Credit Programs

Federal Low Income Housing Tax Credits

The Authority's Tax Credit Programs received 120 applications for consideration. Of these applications, 90 applications were submitted for the federal Low Income Housing Tax Credit (Federal Tax Credit) seeking a total of 256,256,255 in Federal Tax Credit allocations. If funded, these projects would have provided an additional 8,338 units of affordable housing.

State Tax Credits (Illinois Affordable Housing Tax Credits)

The remaining 30 applications were submitted for the Illinois Affordable Housing Tax Credit (State Tax Credit) seeking a total of 34,951,451 in State Tax Credit allocations that, if approved, would have assisted the creation of 1,894 units of affordable housing.

National Housing Trust Fund

NHTF was established as a permanent federal program, with dedicated sources of funding coming from a percentage of after-tax profits from the Government Sponsored Enterprises (GSEs) Fannie Mae and Freddie Mac, which are not subject to the appropriations process. The Authority received a total of 5 applications seeking \$24,305,795 in financing that, if awarded, would have provided an additional 112 units of housing for the state. There were an additional 17 applications received through the Permanent Supportive Housing (PSH) Program, which can be funded with NHTF monies. PSH applicants are listed in EXHIBIT VII: FY2022 Applications Report – Other Multifamily Financing Requests. All the applications received were for multifamily housing.

Illinois Affordable Housing Trust Fund

The Authority received a total of 2 applications seeking \$5,200,000 in financing that, if awarded, would have provided an additional 89 units of housing for the state. There were an additional 17 applications received through the Permanent Supportive Housing (PSH) Program, and some of these were funded with Trust Fund monies. PSH applicants are listed in EXHIBIT VII: FY2022 Applications Report – Other Multifamily Financing Requests. All the applications received were for multifamily housing.

Rental Housing Support Program

The Rental Housing Support Program (RHSP) was signed into law through Public Act 94-118, the Rental Housing Support Program Act, to create a rental assistance program for extremely low-income households in the state. RHSP is divided into two sub-programs: (i) the Rental Housing Support Program, which allows the Authority to contract with agencies throughout the state called Local Administering Agencies (LAAs); and (ii) the Long Term Operating Support Program (the LTOS Program), which allows the Authority to directly contract with owners of rental developments. Funding for the two programs is allocated based on a formula in the enabling legislation.

The RHS-LAA Program renewed 13 contracts in FY2022 to continue participation in the program. Contract requests for funding totaled \$11,655,130, representing an estimated 356 units that would be assisted throughout the state.

Other Multifamily Financing Requests

IHDA received 45 requests for \$118,498,748 in gap financing that would generate 2,434 in affordable units if funded. These other financing requests represent a subordinate resource request. This funding depends on the availability of funds in various programs including HOME, Trust Fund, Bond, Financing Adjustment Factor (FAF), National Housing Trust Fund, State Tax Credits, and Federal Tax Credits. Additionally, IHDA received 17 applications for the Permanent Supportive Housing Development Program, which is funded through three sources: HOME Investment Partnership Program, National Housing Trust Fund, and Illinois Affordable Housing Trust Fund. IHDA received 2 applications for the Long Term Operating Support Program. Finally, IHDA received 122 applications for Capital Bill-funded programs: 87 applications for \$37,476,365 from the Capital Bill Preservation Program that would generate 5,423 in affordable units if funded, and 35 applications for \$16,604,759 from the Housing for Justice Involved Individuals Program (HJIIP), which would generate 143 units if funded.

Illinois Affordable Housing Trust Fund - Single Family Trust Fund

The Authority's Single Family Trust Fund (Trust Fund) programs are housed in the Community Affairs Department (CA). In FY2022, active programs consisted of the Community Impact Loan Fund - Habitat for Humanity, the Home Accessibility Program, the Single-Family Rehabilitation Program, the Chicago Rehab Network Technical Assistance Grant, and the Land Bank Technical Assistance Program Grant. Active programs are currently in a two-year funding cycle.

Community Impact Loan Fund – Habitat for Humanity

The applicant applies periodically as part of the funding approval process for this program.

Home Accessibility Program

The applicant applies periodically as part of the funding approval process for this program. In FY2022, no application funding rounds were held for this program.

Single Family Rehabilitation Program

The applicant applies periodically as part of the funding approval process for this program. In FY2022, no application funding rounds were held for this program. However, due to the COVID-related issues for the programs, a final operational extension was presented to IHDA's Board on March 2022 for Single-Family Rehabilitation Program Round 2 and Round 3 to extend both until December 2022.

Technical Assistance Grant (Chicago Rehabilitation Network)

The applicant applies periodically as part of the funding approval process for this program.

Land Bank Technical Assistance Program Grant

The Technical Assistance Providers apply periodically as part of the funding approval process for this program.

Community Affairs Programs

On behalf of the Authority, Community Affairs administers a series of programs to provide funding and technical assistance to Illinois units of local government to support housing focused community revitalization measures to address vacant and/or abandoned distressed residential properties. In FY2022, active programs consisted of the Abandoned Properties Program, Land Bank Capacity Program and Technical Assistance Network, and the Strong Communities Program. In FY2022, 3 applications were received by the Authority, totaling \$205,000 in grant requests. Funding information for individual active programs can be found below.

Abandoned Properties Program

Under the Abandoned Properties Program (APP) no application funding rounds were held in FY2022. As a result of the Illinois Supreme Court's 2021 decision in Walker v. Chasteen, which found the program's funding mechanism to be unconstitutional, no future application funding rounds are planned for this program.

Land Bank Capacity Program and Technical Assistance Network

The Land Bank Capacity Program (LBCP) and Technical Assistance Network (TA Network) assist communities outside the Chicago metropolitan area, with an emphasis on downstate and southern Illinois, by providing grant funds to help empower local and regional revitalization efforts through increased planning and land bank capacity. Funds are provided to units of local government and to technical assistance providers for initial capital to fund start-up costs of creating a land bank, operating costs, costs for land acquisition, and other locally managed revitalization techniques. The technical assistance component of the grant is dedicated to increasing development capacity for those communities seeking to form land banks. Funding is derived solely from a national settlement with the nation's largest banks, secured by Illinois' Attorney General, in conjunction with other state attorneys general, the U.S. Department of Justice, and the U.S. Department of Housing and Urban Development. A Request for Applications for additional funding enabled by a reallocation of existing but unspent and de-obligated program funds was released on December 17th,

2021, and due by January 12th, 2022. A total of 3 applications were received totaling \$205,000 in requests.

Strong Communities Program

The Strong Communities Program (SCP) was established with \$30,000,000 of the total \$200,000,000 in funds appropriated from the Build Illinois Bond Fund to the Department of Revenue for the Illinois Housing Development Authority. SCP grants funds to units of local government throughout the state to address local affordable housing needs and community revitalization efforts. The Program aims to return vacant residential properties to productive and taxable use through rehabilitation, and it provides funds for demolition in cases where properties are beyond repair and negatively impacting neighboring residences. As a result, SCP will increase property values, create jobs, help reduce crime, generate additional tax revenue, and attract further community investment. IHDA, in connection with the Strong Communities Program, replaced the remaining unused portions of the Abandoned Property Program (APP) Round 5 grant awards with SCP grants. A total of 48 APP R5 grantees requested replacement awards under Round 1.5, totaling \$4,309,403.92. In FY2022, IHDA did not release an application for round 1.5.

Housing Counseling Programs

On behalf of the Authority, the Community Affairs Department administers programs which provide operational and capacity building funding to HUD approved housing counseling agencies and community-based organizations, which in turn supports housing counseling, financial literacy, and organizational capacity building across the state. In FY2022, the Authority received a combined 53 applications totaling \$9.22 million in grant requests. Funding information for individual active programs can be found below.

Foreclosure Prevention Program

Under the Foreclosure Prevention Program (FPP), no application funding rounds were held in FY2022. As a result of the Illinois Supreme Court's 2021 decision in Walker v. Chasteen, which found the program's funding mechanism to be unconstitutional, no future application funding rounds are planned for this program.

Foreclosure Prevention Program Graduated Fund

Under the Foreclosure Prevention Program – Graduated Fund (FPPG), no application funding rounds were held in FY2022. As a result of the Illinois Supreme Court's 2021 decision in Walker v. Chasteen, which found the program's funding mechanism to be unconstitutional, no future application funding rounds are planned for this program.

Cook County Mortgage Foreclosure Mediation Program

The Cook County Mortgage Foreclosure Mediation Program (CCMFMP) was first established in 2010 in response to the economic recession and related mortgage crisis, which began in 2008. The program was designed to provide Cook County homeowners in foreclosure with critical support and to help them explore their options to either stay in their homes or negotiate a respectable exit as early as possible once the foreclosure process begins. IHDA manages the helpline and housing counseling agency components of the grant. This initial iteration of the program ceased activity in 2017 but was reopened in 2021 as a response to the risk of rising foreclosures due to the COVID-19 pandemic. Funding is derived from the American Rescue Plan Act of 2021. For FY2022, IHDA did not release an

application, however, Cook County the funder requested to extend its existing program agreement with the Authority along with providing approval to extend the sub-grantee agreements IHDA maintains with the existing awarded organizations. Additional funds are to be provided through November 30, 2024, before the expiration of the current agreement.

Housing Stability Counseling Program

In 2021, IHDA was awarded a counseling grant from NeighborWorks America for the Housing Stability Counseling Program (HSCP) of \$2,858,550. The program is intended to support the delivery of housing counseling services by HUD-approved housing counseling agencies, for those facing housing instability, such as eviction, default, foreclosure, loss of income, or homelessness. Funding is derived from the American Rescue Plan Act of 2021. A Request for Applications was released in July 2021, and 22 applications were received totaling \$4.8 million in requests.

Housing Counseling Resource Program

The Housing Counseling Resources Program (HCRP) is a new 3-year program funded by the Federal Home Loan Bank of Chicago, which will provide \$1 million in annual grants to HUD-approved housing counseling agencies across Illinois to expand organizational capacity and services to reach minority and low- and moderate-income homebuyers. A Request for Applications was released in January 2022, and 31 applications were received totaling \$4.4 million in requests.

Housing Stability Services for the Illinois Rental Payment Program

Housing Stability Services (HSS) for the Illinois Rental Payment Program Round 2 (ILRPP2) is funded by the U.S. Department of Treasury, Section 3201 of the American Rescue Plan of 2021 (ARPA) authorizes Treasury to make payments to certain Recipients, including the State of Illinois, to be used to provide emergency rental assistance. HSS agencies were utilized to assist with administering the ILRPP 2 by conducting outreach and intake for the rental assistance component. In FY2022, IHDA held an application funding round (Round 2.0), which received 71 applications totaling \$7.9million in grant requests.

Homeowner Financed Mortgages

During FY2022, the Authority, under its Homeownership Programs received applications for 7,242 loans totaling \$1,135,821,141 in first mortgages. A total of 7,242 of these applicants also applied for down payment assistance totaling \$37,297,740. A description of each Homeownership Program follows:

Access 4%

Access Mortgage became the Illinois Housing Development Authority's flagship mortgage financing program on February 1, 2018. This consists of three programs. The first, Access 4% is designed to increase home purchase accessibility by offering a forgivable second mortgage of 4% of the purchase price (up to \$6,000) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Additionally, a Mortgage Credit Certificate (MCC), which entitles homebuyers to use up to 25% of yearly mortgage interest as a federal tax credit was available for eligible borrowers using this program starting September 1, 2018 (currently no active MCC Program). The entire Access Mortgage program runs statewide for both first-time and non-first-time homebuyers. During FY2022, the Access 4% Program accounted for 1,619 applications, or 23%, of the department's first mortgage applications, totaling \$249,744,838 in first

mortgages. Of these, 1,619 or 100%, applied for down payment assistance in the form of a second mortgage, totaling \$6,468,784. Of the 1,619 applications, 0 or 0.00%, also applied for the mortgage credit certificate totaling \$0.00.

Access 5%

The second program, Access 5% is designed to increase home purchase accessibility by offering a repayable second mortgage of 5% of the purchase price (up to \$7,500) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment will be deferred for 30 years, unless repaid sooner, or in the event of a refinance or sale of the property, at which time the funds will become due. Additionally, a Mortgage Credit Certificate (MCC), which entitles homebuyers to use up to 25% of yearly mortgage interest as a federal tax credit was available for eligible borrowers using this program starting September 1, 2018 (currently no active MCC Program). The entire Access Mortgage program runs statewide for both first-time and non-first-time Homebuyers. During FY2022, the Access 5% Program accounted for 453 applications, or 6%, of the department's first mortgage applications, totaling \$85,133,378 in first mortgages. Of these, 453 or 100%, applied for down payment assistance in the form of a second mortgage, totaling \$2,255,592. Of the 453 applications, 0, or 0%, also applied for the mortgage credit certificate totaling \$0.00.

Access 10%

The third program, Access 10% is designed to increase home purchase accessibility by offering a repayable second mortgage of 10% of the purchase price (up to \$10,000) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment of the second is monthly, amortizing over a 10-year period at 0% interest rate. Additionally, a Mortgage Credit Certificate (MCC), which entitles homebuyers to use up to 25% of yearly mortgage interest as a federal tax credit was available for eligible borrowers using this program starting September 1, 2018 (currently no active MCC Program). The entire Access Mortgage program runs statewide for both first-time and non-first-time Homebuyers. During FY2022, the Access 10% Program accounted for 1,165 applications, or 16%, of the department's first mortgage applications, totaling \$217,426,476 in first mortgages. Of these, 1,165, or 100%, applied for down payment assistance in the form of a second mortgage, totaling \$8,851,365. Of the 1,165 applications, 0 or 0%, also applied for the mortgage credit certificate totaling \$0.00.

Opening Doors

The Authority launched the Opening Doors Program on December 1, 2020. Opening Doors offers a second mortgage of \$6,000 in down payment and/or closing cost assistance forgiven monthly over 5 years with a 30-year fixed rate first mortgage to qualified households across Illinois. During FY2022, the Opening Doors program accounted for 4,005 applications, or 55%, of the department's first mortgage applications, totaling \$583,516,449 in first mortgages. Of these, 4,005, or 100%, applied for down payment assistance totaling \$19,722,000.

SmartBuy

The Authority launched the SmartBuy Program on December 1, 2020, to assist homebuyers affected by increasing student loan debt with purchasing a home in Illinois. SmartBuy offers student loan debt relief provided in the form of a promissory note (up to 15% of the

purchase price, not to exceed \$40,000) that is forgiven monthly over 3 years. SmartBuy also offers a repayable second mortgage of \$5,000 in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment of the second mortgage will be deferred for 30 years, unless repaid sooner, or in the event of a refinance or sale of the property, at which time the funds will become due. During FY2022, the SmartBuy program accounted for 0 applications.

COVID-Related Emergency Funding

The Illinois Rental Payment Program Round 2 (ILRPP 2.0) and the Illinois Homeowner Assistance Fund (ILHAF) programs were created with the American Rescue Plan of 2021 funding in response to the economic crisis caused by the COVID-19 pandemic. Renters who were impacted by COVID-19 and subsequently behind on their rent were awarded \$15,000 in rental assistance to cover past due rent and future rent from June 2020 through April 2022. Impacted mortgage holders received up to \$30,000 in assistance to pay past due mortgage debt and future mortgage payments to avoid foreclosure risk. The ILRPP 2.0 and ILHAF programs launched throughout the state in FY2022. ILRPP 2.0 received 52,651 unique applications, and fully funded all 27,325 eligible and complete applications after a review process in which IHDA worked with applicants to help correct or complete their applications. Over 63% of approved applicants were from households who identified as either African American, American Indian, Asian, or Pacific Islander, and they received over \$155 million in assistance. African American households received the largest share (63%) of funding. ILHAF received more than 14,091 eligible and complete applications and IHDA worked with applicants to help correct or complete their applications.

Using Federal ARPA funds, ILRPP 2.0 was launched in December 2021, to provide a lifeline for renters and landlords who continued to experience financial hardships related to the COVID-19 pandemic. Per program rules, payments could cover missed rent payments as far back as June 2020 and prepay rent through April 2022, or until the \$25,000 was exhausted, whichever came first. IHDA received 27,325 applications from the program's opening through the end of FY2022 (the program continued to accept applications through December 2022).

FINANCING ACTIVITIES IN FY2022

The Authority financed more than \$677,378,089 in Federal and State resources in FY2022. These applications were for the creation or preservation of 8,742 units to the state. The Authority also financed two COVID-Related emergency funding programs, assisting over 75,000 renter households with \$630 million dollars through ILRPP 2.0 and over 14,000 households with \$200 million dollars through ILHAF.

Bonds

During FY2022, the Authority financed approximately \$474,383,329 for first mortgage loans on 19 multifamily developments located in the state. These developments were financed through the Authority's Conduit Bond, Tax Exempt Bond, and Advantage Mortgage Programs, and contain a total of 3,181 units.

HOME Investment Partnership Program

During FY2022, the Authority closed HOME loans totaling approximately \$26,936,376 for 10 multifamily housing developments. A total of 139 HOME units in two counties will be assisted through the loans made during FY2022.

Tax Credit Programs

Federal Low Income Housing Tax Credits

During FY2022, the Authority approved and allocated approximately 26,599,347 in Federal Tax Credits totaling approximately \$218,631,362 (over 10 years/discounted). These developments contain a total of 1,293 units, of which 1,252 units are reserved for low-income households. Federal Tax Credit allocations were used in conjunction with several of the Authority's programs, including the HOME Program, Trust Fund, and State Tax Credit allocations. In addition, tax-exempt bond deals allocated a total of 31,549,480 in Federal (4%) Tax Credits, totaling approximately \$275,549,195, and creating 3,021 units, 2,550 of which were designated for low-income residents.

State Tax Credits (Illinois Affordable Housing Tax Credits)

During FY2022, the Authority approved and allocated approximately 21,648,762 in State Tax Credits. These developments are expected to contain a total of 1,099 units, of which 283 units are reserved for low-income households. State Tax Credit allocations were used in conjunction with several of the Authority's programs including the HOME Program, Trust Fund, and Federal Tax Credit allocations.

National Housing Trust Fund

The National Housing Trust Fund (NHTF) was authorized as part of the Housing and Economic Recovery Act of 2008 and provides rental housing for ELI households at 30% or below area median income. The State of Illinois received \$33,710,562 for program year 2022. IHDA closed one NHTF project in FY2022 and is working towards closing current Board Approved applications.

Illinois Affordable Housing Trust Fund

During FY2022, the Trust Fund received \$60,934,779 from its portion of the proceeds of the Illinois real estate transfer tax. This amount was approximately \$16,747,096 more than the amount

received in FY2021. There were 30 Multifamily Trust Fund projects approved by the Authority's Board in FY2022 for approximately \$40,166,525, assisting to create 951 units. There were 4 closings in FY22 totaling \$12,471,455 and creating 109 units.

Rental Housing Support Program

During FY2022, the Rental Housing Support Program (RHS) received \$17,602,192 from the proceeds of real estate document recording fees. The funds are allocated based on a method outlined in the enabling legislation, which allows for four geographic areas in the state: City of Chicago, Metro Chicago, Small Metro Areas, and Rural Areas. Each area gets a proportionate share of the funds based on its proportion of households at or below 50% AMI, and who are spending 30% or more of the income on rent and utilities. In FY2022, the Authority renewed contracts with 13 LAAs (as defined in Section I-M above), for a total of \$11,655,130 in funding, representing 356 units. There was one award of LTOS funds in FY2022 totaling \$1,160,872.

Other Multifamily Financing Requests

'Other' financing requests represent a subordinate resource request. This funding depends on the availability of funds in various programs including, HOME, Trust Fund, Bond, Financing Adjustment Factor (FAF), State Tax Credits, COVID-19 Affordable Housing Grant Program and Federal Tax Credits.

Illinois Affordable Housing Trust Fund - Single Family Trust Fund

In FY2022, the Single Family Trust Fund supported funding under the Community Impact Loan Fund Program - Habitat for Humanity, Home Accessibility Program, Single Family Rehabilitation Program, the Chicago Rehab Network Technical Assistance Grant, and the Land Bank Technical Assistance Program Grant. A combined \$4,454,598 was disbursed to assist 133 households along with providing technical assistance support across the programs. Financing information for individual active programs can be found below.

Community Impact Loan Fund – Habitat for Humanity

In FY2022, \$265,000 was disbursed to assist 16 low-income qualified homebuyers under Round 4 of the program.

Home Accessibility Program

In FY2022, \$347,728.58 was disbursed to assist 16 households under Round 2 of the program.

Single Family Rehabilitation Program

In FY2022, a combined \$3,362,060.67 was disbursed to assist 101 households under Rounds 2 and 3 of the program.

Technical Assistance Grant (Chicago Rehabilitation Network)

In FY2022, \$149,374.58 was disbursed to provide technical assistance and training under Round 3 of the program.

Land Bank Technical Assistance Program Grant

In FY2022, \$330,434.39 was disbursed to provide technical assistance under Rounds 1 and 2 of the program.

Community Affairs Programs

On behalf of the Authority, Community Affairs administers a series of programs aimed at providing funding and technical assistance to Illinois units of local government, including land banks to support community revitalization measures aimed at addressing vacant and/or abandoned distressed residential properties. In FY2022, active programs consisted of the Abandoned Properties Program, the Land Bank Capacity Program and Technical Assistance Network, and the Strong Communities Program. A combined \$9,207,609.90 was disbursed to assist 1,858 properties. Financing information for individual active programs can be found below.

Abandoned Properties Program

APP assists units of local government with costs incurred for securing, maintaining, or demolishing vacant and abandoned residential properties to assist with revitalization efforts across the state. In FY2022, the Authority disbursed a total of \$6,791,688.43 to finance revitalization activities on 1,502 unique properties under Rounds 4 and 5 of the program.

Land Bank Capacity Program and Technical Assistance Network

LBCP provides funds to units of local government and technical assistance providers for initial capital to fund start-up costs of creating a land bank, operating costs, costs for land acquisition, and other locally managed revitalization techniques. The technical assistance component available in Rounds 1 and 2 is dedicated to increasing development capacity for those communities seeking to form land banks. In FY2022, IHDA received 3 applications for additional funding made available by the reallocation of previously awarded but unspent National Foreclosure Settlement funds which were under IHDA's custody.

Recommendations were presented to the Board on February 18, 2022, who approved an additional \$162,603.38 in combined funding to the 3 existing LBCP Round 2 grantees. In addition, following the reallocation from the Office of the Illinois Attorney General, of unused National Foreclosure Settlement funding, which had previously been earmarked for the Peoria metro area, additional funds were awarded to the City of Peoria, an existing LBCP grantee. In FY2022, IHDA disbursed a combined \$330,434.39 to support activities on 169 properties in addition to technical assistance for program grantees.

Strong Communities Program

SCP provides grant funds to units of local government throughout the state to address local affordable housing needs and community revitalization efforts. The Program aims to return vacant residential properties to productive and taxable use through rehabilitation, and it provides funds for demolition in cases where properties are beyond repair and negatively impacting neighboring residences. As a result, SCP will increase property values, create jobs, help reduce crime, generate additional tax revenue, and attract further community investment. In FY2022, IHDA disbursed \$2,085,486.90 to support activities on 187 properties.

Housing Counseling Programs

In FY2022, IHDA continued disbursing funds under its housing counseling programs to provide operational and capacity-building support to HUD-approved housing counseling agencies and community-based organizations in support of housing counseling, financial literacy, and organizational capacity building. This was especially important considering the ongoing impacts of

the COVID-19 pandemic. Active programs included the Foreclosure Prevention Program, Foreclosure Prevention Program Graduated Fund, Housing Stability Counseling Program, and Housing Counseling Resource Program. In FY2022, a combined \$991,931.74 dollars was disbursed to assist 2,894 households with counseling. A total of 42 approved applications for housing counseling programs. Financing information for individual active programs can be found below.

Foreclosure Prevention Program

FPP, established by 20 ILCS 3805/7.30, provided grants to HUD-approved Housing Counseling Agencies and Community-Based Organizations (CBOs). Funded via foreclosure filing fees paid by plaintiffs to the respective County Clerk. FPP was a reimbursement program for funds already expended by participating agencies for eligible uses. Eligible activities included financial literacy, pre- and post-purchase counseling, foreclosure counseling, staff/counselor training, capacity building, and operational expenses. Funds disbursed under FPP in FY2022 totaled \$374,138.71, assisting 877 households. No funding awards were given under the program in FY2022.

Foreclosure Prevention Program Graduated Fund

FPPG, established by 20 ILCS 3805/7.30(b-1), provided grants to HUD-approved Housing Counseling Agencies. Funded via foreclosure filing fees paid by plaintiffs to the respective County Clerk. FPPG is a reimbursement program for funds already expended by the agencies for eligible uses. Eligible activities included financial literacy, pre- and post-purchase counseling, foreclosure counseling, staff/counselor training, capacity building, and operational expenses. Disbursements under FPPG in FY2022, were \$617,465.87, serving 1,144 households. No funding awards were given under the program in FY2022.

Cook County Mortgage Foreclosure Mediation Program

CCMFMP was first established in 2010 in response to the economic recession and related mortgage crisis, which began in 2008. The program was designed to provide Cook County homeowners in foreclosure with critical support and to help them explore their options to either stay in their homes or negotiate a respectable exit as early as possible once the foreclosure process begins. IHDA manages the helpline and housing counseling agency components of the grant. This initial iteration of the program ceased activity in 2017 but was reopened in 2021 as a response to the risk of rising foreclosures due to the COVID-19 pandemic. Funding is derived from the American Rescue Plan Act of 2021. For FY2022, IHDA did not release an application, however, Cook County the funder requested to extend its existing program agreement with the Authority along with providing approval to extend the sub-grantee agreements IHDA maintains with the existing awarded organizations. Additional funds are to be provided through November 30, 2024, before the expiration of the current agreement.

Housing Stability Counseling Program

In 2021, IHDA was awarded a counseling grant from NeighborWorks for the Housing Stability Counseling Program (HSCP) totaling \$2,858,550. The program is intended to support the delivery of housing counseling services by HUD-approved housing counseling for those facing housing instability, such as eviction, default, foreclosure, loss of income, or homelessness. Funding is derived from the American Rescue Plan Act of 2021. In FY2022, \$2.7 million in funds were awarded to 21 organizations. The program has assisted 873 households in FY2022, and payments for these activities are pending within FY2023.

Housing Counseling Resource Program

HCRP is a 3-year program funded by the Federal Home Loan Bank of Chicago, which provides \$1 million in annual grants to HUD-approved housing counseling agencies across Illinois to expand organizational capacity and services to reach minority and low- and moderate-income homebuyers. Round 1 is effective as of June 2022. In FY2022, \$3 million in funds were awarded to 21 organizations.

Housing Stability Services for the Illinois Rental Payment Program

Housing Stability Services (HSS) for the Illinois Rental Payment Program Round 2 (ILRPP2) is funded by the U.S. Department of Treasury, Section 3201 of the American Rescue Plan of 2021 (ARPA) authorizes Treasury to make payments to certain Recipients, including the State of Illinois, to be used to provide emergency rental assistance. A portion of these funds was used to support the work of the HSS agency partners. HSS agencies were utilized to assist with administering the ILRPP2 by conducting outreach and intake for the rental assistance component. In FY2022, IHDA awarded a combined \$7.1 million to 62 organizations under Round 2.0 of the program. Additionally, a combined \$283,316,037.24 was disbursed to support a final total of 27,325 approved applications for rental payment assistance (certified at program close).

Homeowner Financed Mortgages

During FY2022, the Authority, under its homeownership programs purchased and provided loans for first-time and non-first-time homebuyers. Under this program, the Authority purchased 6,619 loans in 90 of the state's 102 counties totaling \$1,032,673,639 in first mortgages. The breakdown of each homeownership program is as follows:

Access 4%

During FY2022, the Authority's Access 4% Program provided \$144,810,852 in first mortgages to 946 households, or 14% of the program's financing.

Access 5%

During FY2022, the Authority's Access 5% Program provided \$57,369,877 in first mortgages to 302 households, or 5% of the program's financing.

Access 10%

During FY2022, the Authority's Access 10% Program provided \$157,260,753 in first mortgages to 832 households, or 12% of the program's financing.

Opening Doors

During FY2022, the Authority's Opening Doors Program provided \$603,829,009 in first mortgages to 4,214 households, or 64% of the program's financing.

SmartBuy

During FY2022, the Authority's SmartBuy Program provided \$69,403,148 in first mortgages to 325 households, or 5% of the program's financing.

COVID-Related Emergency Funding

The Illinois Rental Payment Program Round 2 (ILRPP 2.0) and the Illinois Homeowner Assistance Fund (ILHAF) programs were created with the American Rescue Plan of 2021 funding in response to the economic crisis caused by the COVID-19 pandemic. Renters who were impacted by COVID-19 and subsequently behind on their rent were awarded a maximum of up to 15 months of rent capped at \$15,000 in rental assistance to cover past due rent and future rent from June 2020 through April 2022. Impacted mortgage holders received up to \$30,000 in assistance to pay past due mortgage debt and future mortgage payments as well other housing assistance like Property Tax, HOA, etc. to avoid foreclosure risk. The programs approved all applicants by December 31, 2021. ILRPP 2.0 assisted over 75,000 renter households with \$630 million dollars and ILHAF assisted over 14,000 households with \$200 million dollars.

PROJECTED ACTIVITIES FOR FY2023

Bonds

The Authority has already closed loans approved by the Board in FY2022, providing 3,181 units of rental housing. The Authority anticipates bringing approximately 11 more projects to the Board in FY2023, which will provide approximately 1,632 additional units of rental housing. This includes Conduit Bond, Tax Exempt Bond, and Advantage Mortgage Programs.

HOME Investment Partnership Program

The Authority will continue to serve as the State's designated administrator (Participating Jurisdiction) of the federal HOME program. The amount of HOME funds allocated to the State FY2022 was \$18,586,872 and the Authority expects approximately \$19,000,000, per HUD's anticipated FY2023 allocation. In FY2023, the Authority will continue to make multifamily loans under the HOME Program to assist low and very low-income households.

Tax Credit Programs

Federal Low Income Housing Tax Credits

The Authority will continue to serve as the State's administrator for Federal Tax Credit allocations. The Authority anticipates that a total of approximately \$33,000,000 in Federal Tax Credit allocations (with approximately \$7,000,000 allocated to the City of Chicago), to be disbursed in FY2023.

State Tax Credits (Illinois Affordable Housing Tax Credits)

The Authority will continue to serve as the State's administrator for State Tax Credit allocations. The Authority anticipates that a total of approximately \$32,850,000 in State Tax Credit allocations (with approximately \$8,048,000 allocated to the City of Chicago), to be disbursed in FY2023.

National Housing Trust Fund

The Authority will continue to serve as the State's designated administrator (Participating Jurisdiction) of the federal NHTF program. The amount of NHTF funds allocated to the State FY2022 was \$33,710,562 and the Authority expects approximately \$30,000,000 in FY2023. In FY2023, the Authority will continue to fund Permanent Supportive Housing and rental properties under 30% AMI under the NHTF Program.

Illinois Affordable Housing Trust Fund

The Authority will continue to serve as the State's administrator for the Affordable Housing Trust Fund. As program administrator, the Authority expects to continue its loan and grant activities in FY2023, although it does not plan to issue any new Trust Fund bonds. Based on the level of real estate sales in the state, the Trust Fund is expected to receive approximately \$65,000,000 of Real Estate Transfer Tax in FY2023 and it will be used to fund grant and loan applications received from around the state. The review of Trust Fund applications will continue to be based on the priorities and guidelines established by the Authority and the Trust Fund Advisory Commission.

The program preserves project-based rental subsidies in existing developments by encouraging owners who acquire and rehabilitate properties to extend existing rental subsidy contracts. The amount of subordinate funding to be provided under Preservation Now will be limited to approximately 10% of the total development costs or the amount necessary to make the project financially feasible, as determined by IHDA. Funding for this program is expected to come from bond cap and/or the Trust Fund.

Rental Housing Support Program

The Authority will continue to serve as the State's administrator for the RHS Program and expects to continue its grant compliance activities for both the RHS Program and the LTOS Program. Based on the level of real estate document recording fees collected in the state, the RHS Program is expected to receive approximately \$12,000,000 in FY2023. The funding will be partially used to renew three-year contracts with LAAs set to expire during FY2023. Additionally, the funding will be used for new grants for additional LTOS properties.

Other Multifamily Financing Requests

'Other' financing requests represent a subordinate resource request. This funding depends on the availability of funds in various programs including, HOME, Trust Fund, Bond, Financing Adjustment Factor (FAF), State Tax Credits, COVID-19 Affordable Housing Grant Program and Federal Tax Credits.

Illinois Affordable Housing Trust Fund - Single Family Trust Fund

Single Family Trust Fund supported funding under the Community Impact Loan Fund Program - Habitat for Humanity, Home Accessibility Program, Single Family Rehabilitation Program, the Chicago Rehab Network Technical Assistance Grant, and the Land Bank Technical Assistance Program Grant.

Community Impact Loan Fund – Habitat for Humanity

In FY2023, disbursement of funds under Round 4 of the program was set to end on February 28, 2023, however an extension of the program's term, until February 27, 2024 (FY2024), was presented to and approved by the IHDA Board on November 18, 2022.

Home Accessibility Program

In FY2023, disbursement of funds will continue for Round 3 of the program which is set to end on August 16, 2023 (FY2024).

Single Family Rehabilitation Program

The disbursement of funds under Rounds 2 and 3 for approved activities is expected to continue during February 2023 (FY2023). All formal program activity ended on December 31, 2022 (FY2023).

Home Repair and Accessibility Program (HRAP)

This program will merge the existing Single Family Rehabilitation Program (SFR) and the Home Accessibility Program (HAP) into one program to reduce the administrative burden for both grantees and IHDA. Other programmatic improvements will also allow the program to help homeowners more effectively. HRAP grantees will be comprised of local governments and nonprofit organizations that will administer the program by working

directly with homeowners. The Home Repair and Accessibility Program (HRAP) will assist low-income and very low-income homeowners with health, safety, and energy efficiency repairs to their homes and accessibility improvements. Through these activities, the program aims to: preserve existing affordable housing stock, provide investment in disadvantaged communities, improve the health and well-being of occupants, and help low-income and disabled or mobility impaired persons remain in their homes.

Eligible homeowners may receive up to \$45,000 in assistance for eligible repairs and/or accessibility improvements. A “Roof Only” option will allow grantees to address roof-related repairs for homes that do not have significant interior health and safety issues or accessibility needs. Homeowners participating in the Roof Only option may receive up to \$21,500 for construction costs. Assistance for all projects will be provided through forgivable loans. Grantees can transfer homeowners from Roof Only to full rehabilitation if they discover other health and safety issues; however, they may not combine these two options on a single house.

The HRAP application, released on August 11, 2022, and due on September 8, 2022, generated significant grantee interest. IHDA received 48 grantee applications for the program, a 41% increase in unique applications compared to SFR Round 3 and HAP Round 3. Applicants also requested approximately \$35,000,000 in total funding. After reviewing and scoring applications, IHDA awarded \$16,000,000 in funding to 38 grantees on December 16, 2023. The first round of HRAP will start on March 15, 2023 and will run for two years before ending on March 14, 2025 unless otherwise extended.

Technical Assistance Grant (Chicago Rehabilitation Network)

The final disbursement of funds under Round 3 is expected to be completed in early FY2023, with program activity ending on September 1, 2022 (FY2023). Round 4 of the program was granted \$330,000, closed with the legal team in September of 2022 (FY2023), and will run for a 2-year term (FY2025).

Land Bank Technical Assistance Program Grant

The final disbursement of funds under Round 1 is expected to be completed in FY2023, with program activity ending on December 17, 2022 (FY2023). Round 2 of the program was granted \$500,000 and closed with IHDA’s legal team in December 2022 (FY2023), with the final program activity slated for December 2025 (FY2025).

Community Affairs Programs

Abandoned Properties Program

As a result of the Illinois Supreme Court’s 2021 decision in *Walker v. Chasteen*, which found the program’s funding mechanism to be unconstitutional, no future application funding rounds are planned for this program.

Land Bank Capacity Program and Technical Assistance Network

In FY2023, the Authority continued disbursing funds to grantees in both rounds, with Round 1 activity ending in August of 2022 (FY2023) and Round 2 program activity ending on August 18, 2022 (FY2023). The Authority will continue to work with the City of Peoria with

activity ending October 19, 2023 (FY2024). Due to lack of funding, no additional application funding rounds are planned for this program.

Strong Communities Program

SCP is currently running two rounds, with a possible 6-month extension for Round 1, which will be presented to the IHDA Board in March 2023, and if approved, program activity will end in October 2023 (FY2024). Round 1.5, an extension to Round 1 to supplement the Abandoned Properties Program, is scheduled to end on April 18, 2024 (FY2024). The Authority is planning to launch a Round 2 application in FY2024.

Housing Counseling Programs

Foreclosure Prevention Program

As a result of the Illinois Supreme Court's 2021 decision in Walker v. Chasteen, which found the program's funding mechanism to be unconstitutional, no future application funding rounds are planned for this program.

Foreclosure Prevention Program Graduated Fund

As a result of the Illinois Supreme Court's 2021 decision in Walker v. Chasteen, which found the program's funding mechanism to be unconstitutional, no future application funding rounds are planned for this program.

Cook County Mortgage Foreclosure Mediation Program

CCMFMP was first established in 2010 in response to the economic recession and related mortgage crisis, which began in 2008. The program was designed to provide Cook County homeowners in foreclosure with critical support and to help them explore their options to either stay in their homes or negotiate a respectable exit as early as possible once the foreclosure process begins. IHDA manages the helpline and housing counseling agency components of the grant. This initial iteration of the program ceased activity in 2017 but was reopened in 2021 as a response to the risk of rising foreclosures due to the COVID-19 pandemic. Program activity is expected to continue across the remainder of FY2023, with the final termination date set for November 30, 2024 (FY2025). Additional application rounds are expected for this program in FY2023.

Housing Stability Counseling Program

On September 28, 2021, NeighborWorks America announced a grant of \$2.7 million for IHDA to administer activity under HSCP. The program is intended to support the delivery of housing counseling services by HUD-approved housing counseling for those facing housing instability, such as eviction, default, foreclosure, loss of income, or homelessness. Funding is derived from the American Rescue Plan Act of 2021. HSCP was initially scheduled to run for one year, with the final activity planned to end on February 28, 2023 (FY2023). A one-year extension into FY2024 was announced in February 2023.

Housing Counseling Resource Program

HCRP is a new 3-year program funded by the Federal Home Loan Bank of Chicago, which will provide \$1 million in annual grants to HUD-approved housing counseling agencies across Illinois to expand organizational capacity and services better to reach minority and

low- and moderate-income homebuyers. Program activity is expected to continue throughout FY2023, with a planned termination in June 2025.

Housing Stability Services for the Illinois Rental Payment Program

Housing Stability Services (HSS) for the Illinois Rental Payment Program Round 2 (ILRPP2) is funded by the U.S. Department of Treasury, Section 3201 of the American Rescue Plan of 2021 (“ARPA”) authorizes Treasury to make payments to certain Recipients, including the State of Illinois, to be used to provide emergency rental assistance. A portion of these funds was used to support the work of the HSS agency partners. HSS agencies were utilized to assist with administering the ILRPP2 by conducting outreach and intake for the rental assistance component. We anticipate continuing using the services of the HSS agency partners to support the operation of our existing and upcoming programs.

Homeowner Financed Mortgages

In FY2023, the Authority anticipates financing approximately \$979 million in first mortgages available to first-time and non-first-time homebuyers. Additionally, the Authority anticipates financing approximately \$46.14 million in second mortgages for down payment assistance and issuing \$0.00 million in Mortgage Credit Certificates (MCC's). During FY2023, the Authority anticipates assisting approximately 6,619 households.

Access 4%

Access 4% is designed to increase home purchase accessibility by offering a forgivable second mortgage of 4% of the purchase price (up to \$6,000) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. The Authority anticipates funding \$592.91 million in first mortgages and \$18.12 million in assistance during FY2023, assisting approximately 3,860 households through the Access 4% program.

Access 5%

Access 5% is designed to increase home purchase accessibility by offering a repayable second mortgage of 5% of the purchase price (up to \$7,500) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment will be deferred for 30 years, unless repaid sooner, or in the event of a refinance or sale of the property, at which time the funds will become due. The Authority anticipates funding \$97.82 million in first mortgages and \$3.21 million in assistance during FY2023, assisting approximately 535 households through the Access 5% program.

Access 10%

Access 10% is designed to increase home purchase accessibility by offering a repayable second mortgage of 10% of the purchase price (up to \$10,000) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment of the second is monthly amortizing over a 10-year period at 0% interest rate. The Authority anticipates funding \$179.38 million in first mortgages and \$8.52 million in assistance during FY2023, assisting approximately 972 households through the Access 10% program.

Opening Doors

The Authority launched the Opening Doors Program on December 1, 2020. Opening Doors offers a second mortgage of \$6,000 in down payment and/or closing cost assistance forgiven monthly over 5 years with a 30-year fixed rate first mortgage to qualified households across Illinois. The Authority anticipates funding \$0.00 million in first mortgages and \$0.00 million in assistance during FY2023.

SmartBuy

The Authority launched the SmartBuy Program on December 1, 2020, to assist homebuyers affected by increasing student loan debt with purchasing a home in Illinois. SmartBuy offers student loan debt relief provided in the form of a promissory note (up to 15% of the purchase price, not to exceed \$40,000) that is forgiven monthly over 3 years. SmartBuy also offers a repayable second mortgage of \$5,000 in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment of the second mortgage will be deferred for 30 years, unless repaid sooner, or in the event of a refinance or sale of the property, at which time the funds will become due. The Authority anticipates funding \$108.38 million in first mortgages and \$16.28 million in assistance during FY2023, assisting approximately 514 households through the SmartBuy program.

COVID-Related Emergency Funding

Using federal Consolidated Appropriations Act of 2021, the Illinois Rental Payment Program (ILRPP) was launched in May 2021, to provide a lifeline for renters and landlords who continued to experience financial hardships related to the COVID-19 Pandemic. Supported by more than \$584 million in federal funding, ILRPP was one of the first statewide programs in the country to fully disburse 100 percent of available funds. This funding assisted 63,964 low-and extremely low-income Illinois renters to stay safe at home and avoid eviction during the pandemic. IHDA received 101,694 completed applications from both renters and landlords in all 102 counties throughout Illinois. Per program rules, payments could cover missed rent payments as far back as June 2020 and prepay rent through August 2021, or until the \$25,000 was exhausted, whichever came first.

Through the American Rescue Plan Act of 2021 (ARPA), a second iteration of the Illinois Rental Payment Program (ILRPP 2.0) was launched in December 2021. With approximately \$300 million committed to this second round of funding, we expected to assist 35,000 households throughout the State of Illinois.

Using federal Consolidated Appropriations Act of 2021, the Illinois Department of Human Services (IDHS), in partnership with IHDA launched a Court-Based Rental Assistance Program (CBRAP) available to tenants and landlords across the state (except for Cook County). With the allocation of up to \$60 million for the CBRAP program, this program was designed to assist renters in eviction court. Renters must have experienced financial hardship, directly or indirectly, due to the pandemic and may qualify for a one-time grant matched to their specific need to cover up to 12 months of past due rent and 3 months of future rent to prevent eviction and homelessness.

Additionally, using ARPA funds, a second iteration of the Illinois Homeowner Mortgage Assistance Fund (ILHAF) is scheduled to launch in early 2023. With 200 million committed, IHDA expects to assist 14,000 homeowners throughout the state and target 57 Illinois zip codes where the most vulnerable homeowners reside. Overall, the ILHAF program progress will be measured by the

number of foreclosures prevented and the number of homeowners assisted in reducing their mortgage delinquency among the targeted populations. In addition, IHDA will contract with a network of housing counseling agencies and legal aid organizations to provide support to those individuals that need additional assistance or face language and technology barriers.

Using ARPA funds, IDHS, in partnership with IHDA launched the Asylum Seeker Emergency Assistance Program (ASERAP) to assist families and individuals seeking asylum, totaling approximately 3,700 persons transported on approximately 90+buses from Texas. With the allocation of \$28.5 million for the ASERAP program, this program was designed to assist asylum seekers in emergency rental assistance via an application process. This program will be in form of a one-time grant up to \$15,000. This grant may provide up to three months of rental assistance (plus move-in fee when applicable) for eligible participants, with the option of one three-month renewal, not to exceed six months of rental assistance total, as individuals transition from temporary hotel stays into affordable housing.

STRATEGIC PLANNING AND REPORTING

The annual Governor's Report is prepared by the Strategic Planning and Reporting Department (SPAR). SPAR works to inform, bolster, and advise the Authority's planning and financing functions with transparent data and metrics, reliable reporting, and critical in-depth analysis. SPAR was formed in 2012 with the mission to improve IHDA's planning, funding, and decision-making capabilities via informed, transparent, and well-balanced analysis and reporting.

In 2016, SPAR merged with other internal departments and teams, combining many important disciplines in the affordable housing world under one roof – housing high need populations, consolidated and comprehensive planning, legislative and financial analysis, market analysis and analytics, technical assistance, navigation of federal regulations, data purification, and database development and administration. SPAR is a one-stop shop for affordable housing analysis that incorporates IHDA's market analysis, housing coordination activities, planning, data collection, policy analysis, research, best practices, and funding reporting activities. SPAR works in concert with all IHDA's departments in and out of funding rounds to better identify and advance the mission and goals of The Authority.

SPAR's broad spectrum of expertise is used to provide IHDA and its partners with thorough information and thoughtful analysis. Key initiatives managed by SPAR for IHDA include:

Community Revitalization Planning: IHDA offers free proactive planning services to communities throughout Illinois. Through these partnerships, IHDA planners work alongside local residents, leaders, and organizations to develop tangible revitalization strategies for their communities. Community Revitalization strategies and activities are also incentivized within IHDA's Low-Income Housing Tax Credit (LIHTC) program; IHDA's Community Revitalization staff is available to provide technical assistance to sponsors and communities seeking to submit their strategies within a LIHTC application.

Statewide housing planning:

- The Illinois Housing Blueprint – A 3–5-year statewide planning initiative that aims to create a vision for the future of equitable affordable housing in Illinois and lay out a plan for achieving it.
- Annual Comprehensive Housing Plan – An annual statement of statewide housing priorities and funding availability, created through the (IHDA-led, SPAR-staffed) Housing Task Force and Illinois Housing Blueprint, and increasingly informed by all statewide affordable housing planning.
- Consolidated Plan - IHDA coordinates the Consolidated Plan for all of Illinois. The Consolidated Plan brings roughly \$90 million in federal block grant programming to Illinois annually and must align with statewide affordable housing planning.
